Notice Inviting Bid

IGPR&GVS invites limited bid for total and permanent bat control & removal in the Institute. The interested/prospective bidders have to submit their bids upto 23.05.2017 till 1.00 P.M.. The estimated bid value is Rs. 80,000/-

Along with the financial bid, the bidders must submit the following documents:-

1. Firm's Registration certificate
2. Copy of PAN and Aadhar Card
3. Copy of Service tax registration
4. Self declaration for not being blacklisted anywhere in the Country.
5. Certificate of Work experience of similar nature of service providing for at least 3 years.

General Terms & Conditions:-

1. The duly filled bid should be legible and the quoted rates should be unconditional.
2. The interested bidders have to deposit Rs. 2000/- as the bid security in form of Cash/DD in favour of Director General, IGPR&GVS along with the bid.
3. The successful bidder has to employ/use his own staff as per requirement and devices, repellents and lights etc required for the task as per the certified standards/norms set by the concerned recognized authority on his own and the Institute would not bear the cost for the same and the firm would ensure the those devices/lights and repellents (Ultra-sonic) would be permanently in the Institute.
4. The successful bidder would ensure that poisonous sprays of any kind would not be used so as to avoid any kind of respiratory hazards.
5. Any harm/damage to the labour employed by the successful firm would be at the contractor's own risk.
6. The firm would ensure that there would be no environmental hazards & harmful side-effects of those repellents and devices for the persons and property in the Institute.
7. The contracted firm would ensure 100% bat removal, deterrence & control in the Institute for the specified period & on the rates finally approved by the Institute. The bill submitted finally, would not be in excess of the approved rates in any case.
8. The successful bidder would have to sign an agreement on a Rs. 500/- Non Judicial stamp and have to deposit 5% of the Institute.
9. The firm would ensure its representatives to be available on call.
10. The successful bidder would be paid 90% of the approved cost of the job after the successful completion of the task and remaining 10% would be paid and the performance security would be refunded only after the continuance of service providing for continuous 3 months from the date of issue of the work order.
